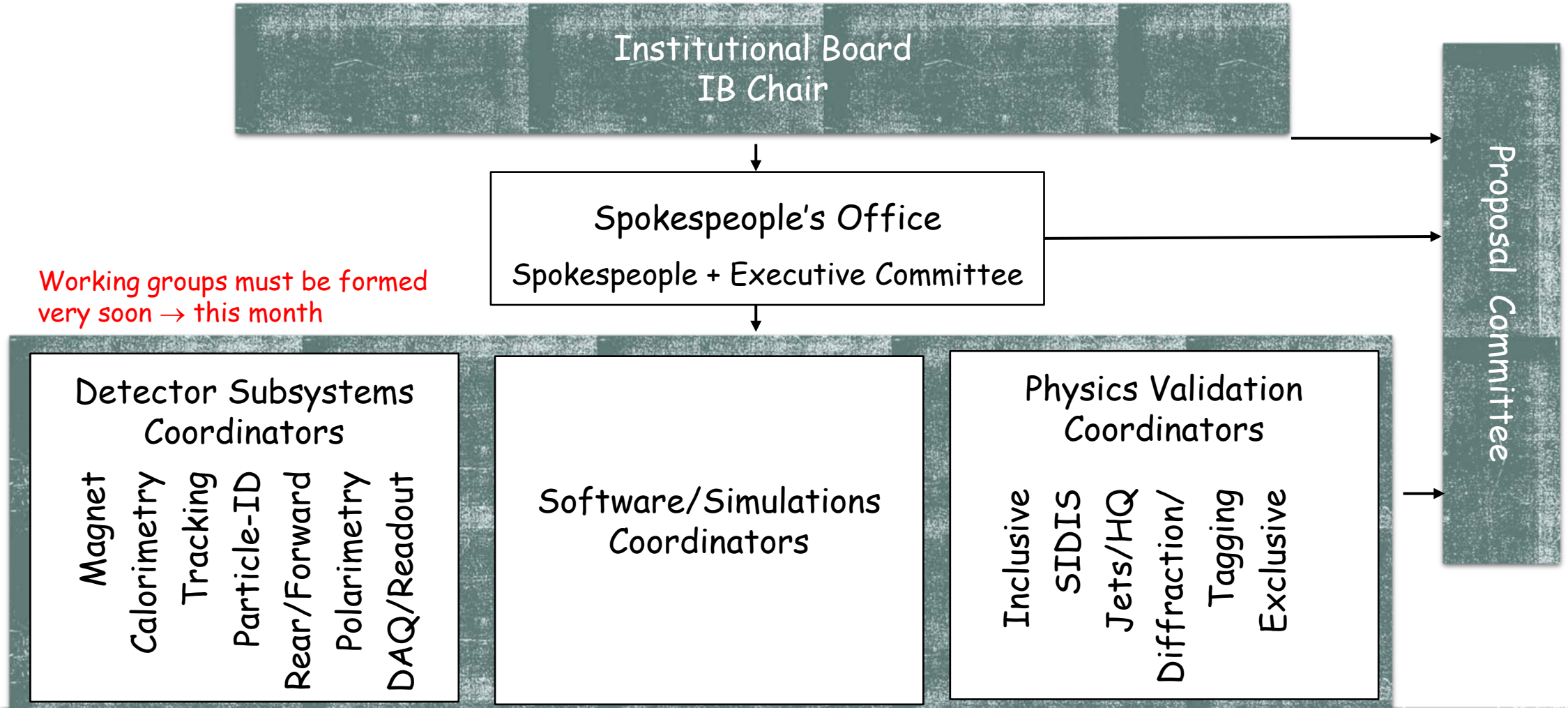
# Collaboration Charter Committee

  - Spokespeople: functions, election process
  - Publication/presentation/authorship policy
