
- We received multiple suggestions and questions for the charter. Thank you all for active engagement in the charter review process!

- Documented responses to written comments were also provided to the IB.
- The revised draft is now under IB consideration for adoption; the adoption vote will start today and is set to close (tentatively) on July 1st. Please participate!
- In the following, I will discuss/clarify some major take-away points from the revision process.



• To avoid confusion, documents are clearly separated after the revision

Collaboration status/Membership:

- We have presented/discussed from the kick-off meeting the plan to develop charter, form a collaboration and elect officially collaboration leadership by/during this summer.
- Comments: what will happen/change at/after proposal selection? What about new groups? What about a merger scenario? Will there be new charter/elections?
 - The Committee feels strongly about proceeding according to initial plan.
 - The Charter has a clear core-value statement on being inclusive and welcoming, and straightforward provisions on accepting new groups. The "new group" requirements are very similar to what was submitted by every ATHENA Institution.
 - The EIC community expressed strongly and continues to stand by the desire for the two detectors, and this is in line with what is requested in the "Call for Proposals." Some regrouping after the proposal decision can be easily accommodated under proposed "new Institution" mechanisms.
 - The IB has a mechanism in place to call for a new Spokesperson election as needed.
 - In the highly undesirable case of only one experiment going forward via some "merger" leading to entirely new collaboration, a new charter/elections will be needed.

Spokesperson/Deputy positions:

- Comments: why not two co-spokespeople? Should both be elected independently? Is the Deputy role a mere placeholder?
 - Both models (S+D and coS+coS) exist in the field; a single spokesperson is the prevailing model (especially in larger experiments).
 - The Committee felt that having one end-point of contact, one final voice for representing the collaboration to the outside world/other experiments/funding agencies, is the optimal model.
 - Having a leadership team of two independently-elected candidates, posses a high risk in terms of compatibility/decision-making ability. Having a leadership team elected together complicates final decision process/creates complications for re-election/unexpected end-of-term situations.
 - The Charter has a clear statement about Deputy Spokesperson role, defining it as a leadership appointment: "The Deputy Spokesperson provides support and assistance to the Spokesperson in the management of the experiment and Collaboration. He/she may be authorized by the Spokesperson to act on his/her behalf and to represent the Collaboration."

Spokesperson election:

- Comments: Should the election be carried by vote of all collaboration members (in good standing)? What if my IB rep does not talk/listen to me?
 - The Committee considered carefully several models of election voting:
 - 1. one vote per group (purely by IB membership)
 - 2. one vote per "Collaborator in Good Standing" (proportional)
 - 3. capped-proportional (current proposal)
 - Option one is prone to dominance by small groups; option two favors large groups
 - Our proposed capped-proportional weighting avoids these two extremes and allows for better balance
 - The revised Election Policy (in addition to provisions to have the whole Collaboration engaged in the process through public announcements and meetings with candidates) spells out clearly expectation for IB members to consult/consider their groups opinion.

Publication Policy:

- Comments: Requirements for preliminary/final results? Handling of un-approved results in dissertations/theses? Final decision on publications?
 - Analysis note is required for both preliminary and final results.
 - All the macros, codes (including calibrations) that are necessary to reanalyze the data and fully reproduce the results (even preliminary) have to be frozen in some repository accessible to the Collaboration and all the documents have to be archived.
 - Generally, un-approved results could not be shown/released to public. Exception is made for internal presentations (think: job interview), grant applications/presentations to funding agencies.
 - Dissertations (that are required to be made public) will have a clear labeling on the plots to avoid any chance for being mistaken for ATHENA result.
 - Seminars could include additional figures that use ATHENA data to illustrate analysis techniques, calibrations, or corrections but such figures could not be used to overwrite or contradict the official ATHENA published results or to release an unapproved physics result or message.
