# RULES

  - *Radio-frequency (RF) transmitting equipment (except when permanently mounted in a vehicle and operating on approved FCC frequencies)*
  - *Alcoholic beverages*
  - *Poisonous or corrosive materials*
  - *Controlled substances including illegal drugs and associate paraphernalia (except prescription drugs in their original containers)*
  - *Other items prohibited by law*

# CSEWG Executive Committee meeting summary

- Big Paper Deadlines:
  - August 1, 2023: Draft of all text & figures
    - This allows for iteration and correction before...
  - September 23, 2023: Final text and figures
  - September 23, 2023: All V&V tables
  - September 23, 2023: Big table of evaluation changes/sources
  - October – all institutional reviews
  - November 1 (ish): submit to Nuclear Data Sheets
    - Given review process, this gets us ONE chance for fixes and gets Big Paper in Mar/Apr issue
- Side papers: Same schedule
  - If you want to make a side paper for your favorite evaluation this is your timeline
- Note: Beta3 is due in September

# CSEWG Executive Committee meeting summary

- Big Paper Authorship:
  - Release lead is first author (whoever is doing this seriously deserves 1k+ first author citations): Gustavo
  - Major contributors, in arbitrary order subject to dispute
  - Everyone else who made a substantive contribution (alphabetically)
    - Dave goes here, but early since “B” is Latin alphabet #2
  - The executive committee is attempting to define what is a “major” and “substantive” contribution
