

### Collaboration Council Meeting past October 27, 2023

### Collaboration Council Meeting past October 27, 2023

A few words on the process for new groups petitioning to join the ePIC Collaboration:

Admission was automatic for the founding institutions; these institutions joined ePIC upon ratification of the Collaboration Charter. For institutions proposing to join the collaboration after the Charter was ratified, the Charter defines a two-step process:

- 1. The institutional representative makes a proposal to the Spokesperson,
- The proposals are then presented to the Collaboration Council for review and vote.

At this stage in the Collaboration's evolution, it seems appropriate to ask proponents to introduce themselves and their institutions to the Collaboration Council, and outline how/where the proponents plan to contribute to the Detector and Collaboration.

All proposals were passed to Collaboration Council via the Spokesperson Office.

Voting was for/against/abstain on the admission of each individual institution. The Charter, section 4.2, stipulates that admission requires a 2/3 super-majority in favor. The Collaboration Council had 185 members as of October 27, 2023. A 2/3 super-majority thus implied a voting threshold of 124.

## Collaboration Council Meeting past October 27, 2023

Voting was for/against/abstain on the admission of each individual institution. The Charter, section 4.2, stipulates that admission requires a 2/3 super-majority in favor. The Collaboration Council had 185 members as of October 27, 2023. A 2/3 super-majority thus implied a voting threshold of 124.

Electronic voting was opened on November 6, 2023 and concluded past Monday, November 27, 2023 at 5pm EST with 139 out of 185 votes cast. Both petitions met with votes in favor by the required super-majority.

Conference and Talks Committee

"The Conference and Talk Committee (CTC) is responsible for the oversight and management of all oral and poster presentations given at scientific conferences on behalf of the Collaboration. This includes the selection of presenters, with the goal of equitable distribution of presentations across the Collaboration, as well as internal quality assurance, approval and archival of presentations, following effective and efficient procedures as detailed in the EPIC conference policy. The committee will assist the Council in developing and enforcing, upon adoption of, the EPIC conference policy. The Conference and Talks Committee, in particular their chair(s), will act as the interface between the collaboration and organizing committees of conferences as appropriate. The committee must have a DEI liaison to assist with equitable distribution of presenting opportunities."

### **Collaboration Council Committees**

Voting was for/against/abstain on the endorsement of the proposed composition of the Membership Committee and, separately, on the proposed composition of the Conferences and Talks Committee. Voting is postponed in the case of the DEI committee in view of an unanticipated change in availability of one of proposed committee members.

Electronic voting was opened on November 6, 2023 and concluded past Monday, November 27, 2023 at 5pm EST with 139 out of 185 votes cast. Convincing majorities voted in favor of the proposed compositions for the Membership Committee as well as for the Conferences and Talks Committee. These Committees are thus endorsed. We will return to the DEI Committee in a future Collaboration Council meeting.

### **Collaboration Council – Executive Board**

Charter: The role of the Executive Board is to counsel the Spokesperson on physics policy, instrumentation choices and candidate suggestions for leadership positions. Three at-large members are elected by the Collaboration Council with one additional member each to be selected by the Diversity, Equity and Inclusion committee and the early career group. The Spokesperson and Deputy Spokesperson(s), if applicable, are ex-officio members. Additional representatives may be appointed by the Spokesperson upon endorsement by the CC. It is expected that top level activity coordinators will be members of the Executive Board.

The terms of the elected at-large members of the Executive Board will be two years and limited to two terms.

Three at-large members were elected by the Collaboration Council in a vote that concluded just before the October 27, 2023 meeting. The at-large members are:

The management plan further identified the Collaboration Council Chair and Vice-Chair as non-voting members.

The Spokesperson and Deputy Spokesperson are ex-officio members by the Charter.

Since no additional members were proposed at the October 27, 2023 meeting of the Collaboration Council, no (further) endorsement vote was deemed necessary and the above thus constitutes the Executive Board membership.
