- The discussion should center about the Safe Conduct of Research principles, and how they can be used in the prevention of Injuries and unwanted events.



Safe Conduct of Research Principles

The Safe Conduct of Research articulates a set of principles that shape behavior and form the basis for a strong safety culture.

- 1. Everyone is personally responsible for ensuring safe operations.
- 2. Leaders value the safety legacy they create in their discipline.
- 3. Staff raise safety concerns because trust permeates the organization.
- 4. Cutting-edge science requires cutting-edge safety.
- 5. A questioning attitude is cultivated.
- 6. Learning never stops.
- 7. Hazards are identified and evaluated for every task, every time.
- 8. A healthy respect is maintained for what can go wrong.
